PROOF OF OWNERSHIP AND REGISTRATION: Occupant shall deliver to Owner prior to occupying the space copies of all documents available to demonstrate proof of ownership of the motor vehicle, boat, or trailer such as Occupant's current registration. Owner shall have the right to refuse Occupant access to the space if the Owner is not satisfied with the documentation of ownership and registration provided by Occupant. Unless the Occupant can provide additional documentation to satisfy the Owner, the Rental Agreement will be deemed to be terminated.

OCCUPANT'S INSURANCE: Occupant shall provide to Owner, prior to occupying the space, copies of all documents available to demonstrate proof of insurance for the motor vehicle, boat, or trailer. Occupant expressly agrees that the insurance company providing such insurance shall not be subrogated to any claim of Occupant against Owner, Owner's agents or employees for loss of or damage to stored property. Occupant understands and agrees that Owner carries no insurance which in any way covers any loss whatsoever that Occupant may have or claim by renting the storage unit or being at the self service storage facility and therefore Occupant must obtain any insurance desired at Occupant's own expense. To the extent Occupant does not maintain such insurance, Occupant shall be deemed to be "self insured" and shall bear all risk of loss or damage.

UNAUTHORIZED VEHICLES/BOATS/TRAILERS: The above described vehicles or boats are the only vehicles permitted to be parked in the assigned space. Occupant agrees that any unauthorized vehicles or other unauthorized items can be removed by Owner at Occupant's expense and that Owner shall not be liable to Occupant for removal of unauthorized vehicles. **No other item (s) shall be stored in the space.**

Occupant agrees not to conduct any repairs or renovations on their vehicles or boats. If occupant rents outside space, occupant agrees to keep vehicles in drivable condition and to keep trailers and other such vehicles road-worthy at all times. Occupant is not permitted to run motor vehicles or boat engines inside the storage space except when entering or departing the space. No portable fuel containers are allowed inside the storage space. No smoking is allowed in any enclosed storage spaces. Interior walls and floors must be protected from oil or spills. Occupant will only park or store in the assigned space or enclosed storage unit the vehicle(s) or boat(s) described in this addendum. Occupant understands that Owner is not a warehouseman or a garage man, and that nothing in this addendum or in the Occupant's use of the premises will be construed as constituting a bailment agreement between the Owner and Occupant. Occupant agrees to keep outside storage space neat and orderly.

Occupant agrees to be bound to the terms and conditions of this Addendum as well as all terms and conditions of the Rental Agreement. Occupant understands and agrees that this Addendum is incorporated by reference into the Occupant's Rental Agreement.
